Final Paper Preparation and Submission Instructions

Dear Author,

Greetings from KIIT (An Institute of Eminence)!

Congratulations for the acceptance of your paper for publication in proceedings of the 2023 2nd *International Conference on Power Electronics and Energy* (ICPEE-2023) to be held on 3rd and 5th January 2023 at KIIT, Bhubaneswar. The following information is provided to help you in the preparation and submission of your final paper as it will be published in the e-proceedings ICPEE-2023 and IEEE digital library as well.

- a) At least one author per paper must pay the registration fee. Registration is required for the publication of your paper; failure to register will result in your paper being removed from the e-proceedings.
- b) Authors are expected to retain the title and author list of the original paper in the final manuscripts.
- c) Each manuscript should not exceed a maximum length of 6 pages. Fees of Rs. 1000 (\$20) per each additional page upto 8 pages will be charged in extra.
- d) Prepare the final version of the camera-ready paper as per the template referring step 1 as mentioned below and pass it through PDF express check.
- e) PDF eXpress is not a file submission system and does not capture files. An author's file simply passes through the system returning a PDF file or an error report. PDF eXpress site ID is **54198X**. [<https://ieeepdf-express.org/Account/Login>]
- f) Change the file name of the PDF Express checked camera ready paper to **PIDxxx (where xxx is your paper ID in CMT)**.
- g) Camera-ready paper passing through PDF Express (PIDxxx) must be submitted through the author console in CMT by **10th December, 2022** (Hard deadline).
- h) Papers not using the right template or that do not pass the IEEE PDF eXpress checklist will be excluded from the proceedings.
- i) The link of the copyright form will be communicated very shortly to the 1st author or corresponding author of the accepted papers. The assigned Author must have to fill up the online copyright form and submit it as per the guidelines of IEEE. Without copyright form the paper may not be considered for publication in IEEE digital library.
- j) You are suggested to follow all steps as mentioned below to ensure the submission process is completed successfully.

Step 1: Formatting the Paper and Submission:

The papers of ICPEE-2023 will be electronically published by IEEE Xplore. It means that accepted papers must exactly fulfil the IEEE requirements regarding the final submitted version.

Please follow strictly the following steps:

1. Modify your paper according to the comments of reviewers and generate the Camera-Ready version of your paper using standard IEEE conference template in double column A4 paper without page numbers. The link for template is as follows:

2. The comments of reviewers are available in the same Microsoft paper management site: <https://cmt3.research.microsoft.com/ICPEE2023>

3. Add the appropriate copyright clearance code notice in the footer of the first page of your paper. In the rest of the pages, the footer will be blank. In the header part of the 1st page, the title of the conference must be cited as **2023 International Conference on Power Electronics and Energy (ICPEE-2023)**.

4. Select the appropriate copyright clearance code notice from the followings:

- a) For papers in which all authors are employed by the US government, the copyright notice is: **U.S. Government work not protected by U.S. copyright**
- b) For papers in which all authors are employed by a Crown government (UK, Canada, and Australia), the copyright notice is: 978-1-6654-7058-2/23/\$31.00 ©2023 Crown
- c) For papers in which all authors are employed by the European Union, the copyright notice is: 978-1-6654-7085-2/23/\$31.00 ©2023 European Union
- d) For all other papers the copyright notice is: 978-1-6654-7058-2/23/\$31.00 ©2023 IEEE

Step 2: PPT Preparation and uploading in Google Drive,

1. Paper presentation is mandatory for anyone of the authors in the allotted slots during conference in virtual mode for submitting the papers in IEEE Digital library.
2. Power point presentation (PPT) of maximum 15 slides should be uploaded in the CMT and it is mandatory for online presenters.

Step 3: Final Paper Inspection.

- a) Your final paper will be checked to ensure that it meets all formatting and compatibility requirements to be included in IEEE Digital Library.
- b) **Plagiarism of final Camera-Ready Paper including references must be below 25% strictly.**
- c) Please make sure that the final version of your accepted paper is very similar to the original submitted paper and this will be checked strictly.
- d) The conference will withdraw any paper that does not meet above requirements.

Note: *A Separate communication will be made to collect the electronic Copy Right Form (e-CF) in due course. Also relevant information will be shared to prepare the video of the presentation for online presentators.*
